) permission to publish the Citation in two newspapers
) viz. "Free Press Journal" in English Language and in
) "Navshakti" in vernacular language i.e. Marathi.

) 3. Perused the Affidavit dated 2nd May 2025
) annexed to Chamber Order. It is stated in he said
) Affidavit that the Citation sent for service upon (i)
) Vinayak Vijay Raipelly, (Son of the deceased). (ii)
) Mangesh Vijay Raipelly, (Son of the deceased) and (iii)
) Kishore Vijay Raipelly, (Son of the deceased), was
) returned by the postal authorities with the remark "Not

) deceased), was returned by the postal authorities with the
