) further stated that the Bailiff has submitted his Report
) dated 30th May, 2015 “that the premises found locked and
) on making enquiry with neighbours of the said premises,
) they inform him that Sangeeta Naresh Dambe (Sister of the
) deceased) is not residing at the said premises but come
) occasionally”. The Applicant has further stated that he
) does not have any other address of said legal heir of the
) deceased. The Applicant therefore requested to permit him
) to serve the Citation upon Sangeeta Naresh Dambe (Sister

) further submits that the Applicant does not have any other
