It is stated in the said Affidavit that the Citation sent for service upon Tarsemlal Harbanslal Sagar (Son of the deceased) was returned by the Bailiff from Sheriff of Bombay and submitted report dated 3rd February 2025 stating therein that the present occupant informed him that the legal heir sold the premises ten years back and his present whereabouts is not known. It is further stated that the Applicant had made diligent search for getting any other address from heirs and relatives but none have been found. The Applicant therefore requested to permit her to publish the Citation upon Tarsemlal Harbanslal Sagar (Son of the deceased) by way of substituted service by publishing in two
