) (NBT)" in vernacular language i.e. Hindi.

) 3. Perused the Affidavit dated 30th April, 2025 annexed to
) Chamber Order. It is stated in the said Affidavit that the
) Citation was sent for service upon Mukesh Chaturbhuj Sahu
) through the Bailiff of Sheriff of Bombay could not be served
) and the Bailiff had submitted his report. It appears from the
) report that the premises was found locked and after making
) enquiry with neighbours that the said legal heirs come their
) occasionally. It is further stated that he had made diligent
) search for getting address of the above legal heir from the
) relatives but none have been found. The Applicant therefore
) requested to permit her to publish the Citation upon Mukesh

) He further submits that Applicant had made diligent search
) for getting address of the above legal heir from the relatives
) but none have been found. He therefore prays that the
) Chamber Order be allowed.
