) for and on behalf of the respondents.

) Heard ld. Advocate for the applicant. Perused
) Affidavit in Support, contents of which are
) self-explanatory. It is contended that
) impugned Order of the Tribunal was passed in
) wrong name and the applicant was in process
) to get said order rectified. However, in the
) meantime, captioned Appeal got dismissed for
) non-compliance of office objections. Ld.
) Advocate for the applicant submits that she
) will get rectified copy of said order within two-
) three weeks and therefore, prays for
) restoration of captioned Appeal.

) Grounds raised on Affidavit, appear to be
) genuine and substantial justice cannot be
) denied on technical ground. Moreover, none
) appeared for the respondents to resist the

) opportunity to pursue with the captioned

) to impose some cost on the applicant so that
