4. Perused Para-10 (A) and 10 (B) of the Petition, it is mentioned and confirmed that the averment made in the Affidavit in respect of the addresses not known to the Petitioner.

5. Heard. The Ld. Advocate for the Applicant submits that the husband of the deceased predeceased and she had no children and the parents of the deceased are also predeceased the deceased. He further submits that there are no heirs of the deceased's husband nor the Petitioner is aware of any heirs of deceased husband. The Ld. Advocate further submits that the Applicant is not aware of above named brother and sisters of the deceased and their whereabouts are not known. He therefore prays that the Chamber Order be allowed.

6. For the reasons stated in Affidavit dated 27th March, 2025 annexed to the Chamber order and averment made in Para-10 (A) and 10 (B) of the Petition, the Chamber Order is allowed. The Applicant is directed to publish the Citation in two newspapers viz. (1) "Free Press Journal" in English and (2) "Hindvasi" in Sindhi language, within four weeks from the date of uploading the order. Office is directed to issue fresh Citation, if required.

7. Applicant to file Affidavit annexing therewith the newspapers within two weeks once, the publication is done.
