) annexed to Chamber Order. It is stated in the said
) Affidavit that the whereabouts of Sandip Samar Das
) alias Sandeep Samar Das (Husband of the deceased) is
) not known to the Applicant. It is further stated that the
) said husband of the deceased had left his home nearly
) 15 years back, when Applicant were minors and since
) then his whereabouts are not known. The Applicants
) have made enquiry at all relevant places to find out
) whereabouts of him, but the Applicants could not trace
) his whereabouts. The Applicants therefore requested to
) permit them to serve the Citation upon Sandip Samar
) Das alias Sandeep Samar Das (Husband of the
) deceased) by way of substituted service by publishing in

) two newspapers viz. "Free Press Journal" in English
) Language and in "Anandabazar Patrika " in vernacular
) language i.e. Bengali.

) minors and since then his whereabouts are not known.

) that the Chamber Order be allowed.
