) Heard ld. Advocate for the applicant. Perused
) Affidavit in Support, contents of which are
) self-explanatory. It is contended that the
) applicant was in process of removing office
) objections with regard to illegible documents
) and translation of voluminous documents,
) however, same could not be complied with
) within stipulated period. Ld. Advocate for the
) plaintiff submits that delay of 76 days caused
) in filing present Chamber Order, which was
) not intentional. He further submits that now
) he will pursue with captioned Suit diligently if
) it is restored to file and prays for restoration of
) captioned Suit by condoning delay.

) Contentions raised in the Affidavit, remain
) uncontested for want of resistance on the part
) of respondents. Hence, I do not hesitate to
) rely on the same for the purpose of restoration
) of captioned Suit. However, it would be just
) and proper to impose certain cost upon the
) applicant so that in future, he will be more
) vigilant in pursuing with captioned Suit.
