By this Chamber Order the Applicant seeks permission to serve the citation upon (1) Rashmi Deven Mehta (widow of predeceased son) and (2) Divya Deven Mehta (Son of predeceased son) of the deceased, by way of substituted service as per schedule annexed to the Chamber Order.

2. Perused the schedule. The Applicant applies for publication of citation in two newspapers viz. “Free Press Journal” in English Language and in “Janmabhoomi” in vernacular language i.e. Gujarati, widely circulated in Mumbai.

3. Perused the affidavit in support. The Applicant has stated in the affidavit that, the citation sent for service upon (1) Rashmi Deven Mehta (widow of predeceased son) and (2) Divya Deven Mehta (Son of predeceased son) of the deceased at their last known address through the Sheriff of Bombay were unserved with a remark “Insufficient address”. It is further stated that, the Applicant had search for the abovenamed legal heirs but their whereabouts are not known. The Applicant, therefore, requested to permit him to publish the citation in two newspapers viz. “Free Press Journal” in

English Language and in “Janmbhoomi” in vernacular language i.e. Gujarati, widely circulated in Mumbai Edition.

4. Heard. Ld. Advocate for the Applicant submits that, the citation sent for service upon (1) Rashmi Deven Mehta (widow of predeceased son) and (2) Divya Deven Mehta (Son of predeceased son) of the deceased at their last known address through the Sheriff of Bombay were unserved with a remark “Insufficient address”. He further submits that, the Applicant had search for the abovenamed legal heirs but their whereabouts are not known. She, therefore, prays that, the Chamber Order be allowed.

5. Perused para 8 of the Petition. For the reasons mentioned in the affidavit in support the Chamber Order is allowed. Applicant to publish the citation in two newspapers viz. “Free Press Journal” in English Language and in “Janmbhoomi” in vernacular language i.e. Gujarati, widely circulated in Mumbai Edition, by way of substituted service of citation upon ALL CONCERNED of the deceased within four weeks from the date of uploading this Order. Applicant to file the affidavit of publication once the citation is published within two weeks thereafter.
