2. Perused the schedule. The Applicant applies for publication of Notice in two newspapers viz. "Free Press Journal" in English Language and in "Navshakti" in vernacular language i.e. Marathi.

3. Perused the affidavit in support. The Applicant has stated in the affidavit in support that, the Applicant had filed the above Petition before this Hon'ble Court for obtaining grant of Probate Petition with Will annexed to the property and credits belonging to Ajit Moreshwar Nadkarni and Vishakha Ajit Nadkarni the deceased being the Legatee named under the last Will and Testament of the deceased. It is further stated that, Mr. Amit Ajit Nadkarni, the son of the deceased predeceased the deceased. It is further stated that, the marriage of Amit Ajit Nadkarni was

dissolved by a judgment and decree dated 20th September 2020 and custody of his daughter Ms. Parvi Amit Nadkarni was with Mrs. Miloni Amit Nadkarni and the deceased and the Petitioner had no relations with them and so the Petitioner is not aware of the said daughter of the predeceased son. The Applicant, therefore, requested to permit her to publish the Notice in two newspapers viz. “Free Press Journal” in English Language and in “Navshakti” in vernacular language i.e. Marathi having circulation in Mumbai, by way of substituted service upon Parvi Amit Nadkarni legal heir of the deceased.

4. Heard. Ld. Advocate for the Applicant submits that, the Applicant had filed the above Petition before this Hon’ble Court for obtaining grant of Probate Petition with Will annexed to the property and credits belonging to Ajit Moreshwar Nadkarni and Vishakha Ajit Nadkarni the deceased being the Legatee named under the last Will and Testament of the deceased.
