By this Chamber Order the Applicant seeks permission to serve the Citation upon ALL CONCERNED legal heirs of the deceased by way of substituted service as per schedule annexed to the Chamber Order.

2. Perused the schedule. The Applicant applies for publication of citation in two newspapers viz. "Free Press Journal" in English language and in "The Sindh Times" in vernacular language i.e. Sindhi.

3. Perused the affidavit in support. The Applicant has stated in the affidavit that, the parents of the deceased No. 1 and wife of deceased No. 1 have predeceased the deceased. The deceased No. 1 died as widower and issueless and had two sisters only. It is further stated that, the heirs of the sisters of deceased No. 1 is not known to the Applicant and during the lifetime both deceased did not mention about whereabouts of their heirs from paternal and maternal side. The Applicant, therefore, requested to permit him to publish the citation by way of service upon ALL CONCERNED legal heirs of the deceased, in two newspapers

viz. “Free Press Journal” in English language and in “The Sindh Times” in vernacular language i.e. Sindhi widely circulated in Mumbai.

4. Heard. Ld. Advocate for the Applicant submits that, the parents of the deceased No. 1 and wife of deceased No. 1 have predeceased the deceased. He further submits that, the deceased No. 1 died as widower and issueless and had two sisters only. He further submits that, the heirs of the sisters of deceased No. 1 is not known to the Applicant and during the lifetime both deceased did not mention about whereabouts of their heirs from paternal and maternal side. He, therefore, prays that the Chamber Order be allowed.

5. Perused paras 10 and 11 of the Petition. For the reasons mentioned in the affidavit in support the Chamber Order is allowed. Applicant to publish the citation in two newspaper viz. “Free Press Journal” in English language and in “The Sindh Times” in vernacular language i.e. Sindhi, widely circulated in Mumbai, by way of substituted service upon ALL CONCERNED legal heirs of the Deceased, within four weeks from the date of uploading this Order. Applicant to file the affidavit of publication once the citation is published within two weeks thereafter.

6. Registry is directed to issue fresh citation, if required.
