INTERIM APPLICATION NO. 4649 OF 2022

“(a) Admit this application and permit the Applicant to intervene in Commercial Admiralty Suit no.32 of 2022 under Rule 1086 of the Bombay High Court (Original Side) Rules, 1980, and be impleaded as a party Defendant in the present Suit and allow the Applicant to file its defence;

(b) Pending the hearing and final disposal of the present Application, this Hon'ble Court be pleased to stay the Suit (being Commercial Admiralty Suit No.32 of 2022) filed by the Respondent / Original Plaintiff.

(c) Costs of this Application.”
