1. The Interim Application seeks restoration of the captioned Commercial
Miscellaneous Petition which came to be dismissed for default.
2. The reply affidavit has been filed opposing the restoration.

3. Having heard learned counsel at some length Mr. Kamod, learned counsel for Respondent No.1 submitted that if the Court was inclined to restore the Petition then the same should be subject to cost.

4. Having heard learned counsel for the Petitioner and having noted the grounds taken in the Interim Application, I am satisfied that the substantive cause of justice would best be served if the Petitioner is given one more opportunity to prosecute the Petition on merits.
