1. Present application is filed for condonation of delay in filing application for restoration of Family Court Appeal No.324/2014. There is a delay of 1755 days in filing application for restoration of the Family Court Appeal.
2. It is submitted that the earlier counsel has not informed to the appellant about dismissal of the matter.
3. The learned Counsel for the respondent submitted that during this period from dismissal to filing of this application for delay condonation, the respondent has performed second marriage. However, we think it

appropriate, it would be settled in mediation if the matter would be referred to the Mediator.

4. As such, though there is delay, it needs to be condoned for the reasons mentioned in the para Nos.3 and 4.

5. Accordingly, the application is allowed. The delay of 1755 days in filing restoration application is hereby condoned. The Registry is directed to register the Misc. Civil Application (St.) No. 2861/2024.

6. The civil application stands disposed of.
