CIVIL APPLICATION (CAF) NO. 1781 OF 2025.

Applicant/appellant has moved the application to delete the name of respondent No.5 from the array of the respondents, as during the pendency of the appeal, he reported to be dead. He was a minor. His legal representatives are already on record. Accordingly, the application is allowed as prayed.

2. Appellant is directed to delete the name of the respondent No.5 from the array of the respondents within a week and supply a copy of the

amended appeal memo to the other side.

3. Application stands disposed of.

CIVIL APPLICATION (CAF) NO. 3716 OF 2024

Applicant/appellant has filed an application to condone the delay of 234 days caused in filing the appeal, for which, learned Counsel for the respondent Nos. 1 to 4 has no objection to condone the delay.

2. Though respondent No.7 is served, none appear for him.

3. Considering the reason disclosed in the application, as well as no objection of the learned Counsel for respondent Nos. 1 to 4, the application is allowed as prayed. As such, the delay is condoned.
