3. This is an application for condonation of delay of 47 days in filing the Appeal challenging the Award dated 05.07.2023 passed by the Presiding Officer, Land Acquisition, Resettlement and Rehabilitation Authority, Nagpur ('The Authority') in Land Acquisition Case No.1260/AMT/AMT/2020.

4. The reason for the delay is attributed to administrative exigencies. The application is supported by affirmation. The respondents have not filed reply disputing the contentions thereof. Therefore, although, the learned Counsel for the respondents opposes the application, I am of the opinion that delay deserves to be condoned in the interest of justice. Hence, the

application is allowed. Delay stands condoned.

5. The Civil Application stands disposed of accordingly.
