ORAL JUDGMENT

. **Rule.** Rule made returnable forthwith. Heard finally
by consent of learned Counsel for the respective parties.

2. In the present writ petition the order passed by the Registrar General and Special Registrar Co-operative Society, Pune, dated 09/05/2024, rejecting the application for review No. 16/2018. The said decision was in view of the judgment of Aurangabad Bench in Writ Petition No. 14387/2019, holding that revision cannot lie, however, the said order was reviewed by the Bench at Aurangabad and review application was allowed. In view of the order dated 12/09/2024, passed in Review Application (Civil) No. 196/2024, the order passed by the Registrar General of Money Lenders and Registrar of Co-operative Societies, Pune, is also needs to be reviewed as there is no other ground for rejecting the application other than the judgment in Writ Petition No. 14387/2019. As order is reviewed and it is held that revision is maintainable before the Registrar General of Money Lenders and Registrar of Co-operative Societies the matter is remitted back to the learned Registrar General of Money Lenders and Registrar of Co-operative Societies, Pune, for fresh consideration.

3. Parties to appear before the Registrar General of Money Lenders and Registrar of Co-operative Societies, Maharashtra, Pune, on 14/05/2025.

4. The interim relief/injunction order by this Court in Clause – (iii) of the order dated 17/12/2024, shall continue during the pendency of revision.

5. Rule is made absolute in the above terms. Pending applications, if any, shall stand disposed of.
