2. Mr. Fulzele, learned Addl.GP for the Respondent No.1/State and Mr. Shinde, learned Counsel for the Respondent Nos. 2 and 3, have no objection to the said amendment.

3. Considering the reasons stated in the application, the application is **allowed** as prayed. The Petitioners are directed to carry out the amendment within two days and supply a copy of the amended Petition to the other side.

4. The Respondents are to file their reply by 28.04.2025.

5. List the matter on **29.04.2025**.

6. Interim order dated 16.01.2025 to continue till then.
