ORAL ORDER:

This is the matter of the year 2013. When this Writ Petition was listed on 10.07.2025, there was no representation on behalf of the Petitioner. This Court had directed the matter to be listed today under the caption 'For Dismissal'. Today also, there is no representation on behalf of the Petitioner.

2. Having regard to the fact that this matter has been pending on the file of this Court since 2013 and that there is no Interim Order, this Court is of the opinion that no useful purpose would be served by keeping this matter pending.
