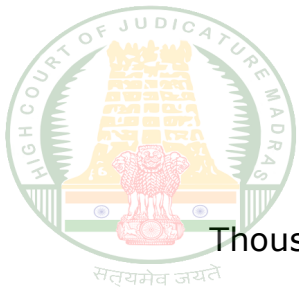
ORDER

The petitioner has filed this writ petition seeking issuance of Writ of Certiorari and call for the records and quash the award dated 26.11.2021 passed in I.D(L).No.50 of 2017 by the Presiding Officer, Industrial Tribunal cum Labour Court, Puducherry.

2.The learned counsel appearing for the petitioner submitted that during the pendency of the writ petition, the matter was settled between the petitioner and respondents and the respondents agreed to receive a sum of Rs.7.5 Lakhs each, in full quit as compensation.

3.The learned counsel appearing for the respondents submitted that the respondents are ready to receive a sum of Rs.7.5 Lakhs each, in full quit as compensation.

4.In view of the consent view expressed by the learned counsel appearing on either side, this Court directs the petitioner Management to pay a sum of Rs.7,50,000/- (Rupees Seven Lakhs and Fifty

Thousand Only) each, in full quit to the respondents, within a period of four weeks from the date of receipt of a copy of this order.
