2. The learned counsel for the petitioner is directed to issue Private notice to the fourth respondent.

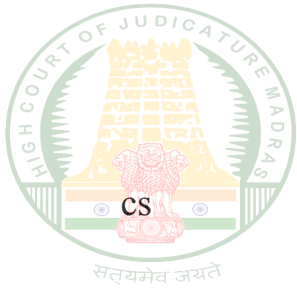
