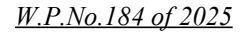

prisoner is sick, though correct, there are other relatives available to take care of the mother of the prisoner. Since the prisoner maintained good conduct inside the prison for seven years and two months, we are inclined to pass the following order:-

- (i) The impugned order passed by the third respondent dated 13.12.2024 is set aside.
- (ii) The prisoner, namely, Divakaran, S/o Durairaj, Convict No.16230 (PID No.53939), is granted 21 days ordinary leave without escort.
- (iii) The leave shall commence from 31.01.2025 10.30 A.M., and the prisoner shall surrender before the third respondent by 5.30 P.M., on 20.02.2025.
- (iv) The prisoner shall appear before the T-3, Korattur Police Station, Chennai twice in a week i.e., on every Monday and Thursday at 11.00 A.M. during the period of leave.

The writ petition stands allowed on the above terms. No costs.
