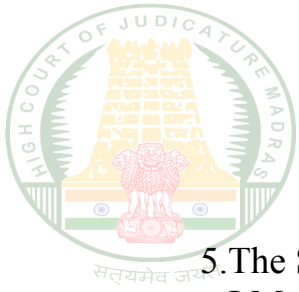

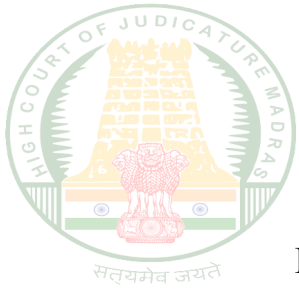

ORDER

2. It is submitted that the issues raised in the present writ petition are identical to those raised in W.P. No. 197 of 2025, which was heard and disposed of by this Court by directing the respondents to consider the petitioner’s representation dated 23.12.2024, after affording an opportunity of personal hearing and to pass appropriate orders on merits in accordance with law. 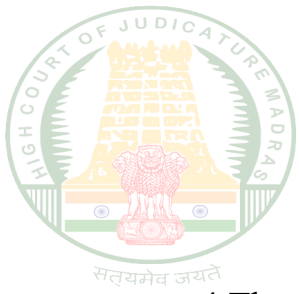
