ORDER

(Order of the Court was made by S.M.SUBRAMANIAM,J.)

The writ of habeas corpus has been instituted to direct the second respondent to produce the detainee Sivaranjani.

2. The petitioner claims to be the husband of the detainee. The detainee has appeared through video conferencing with the assistance of her lawyer. We have examined the detainee. The detainee has completed M.Com degree. She said that she has not married the petitioner. Presently she is living with her parents and she expressed her willingness to continue to live with her parents. Thus the detainee is not under illegal detention. The petitioner is directed not to interfere with the life of the detainee anymore. In the event of any such interference, the detainee or her parents may approach the jurisdictional police for initiation of appropriate action. With these
