2. Counsel for petitioners seeks leave to withdraw the petition. He has also made an endorsement to that effect.

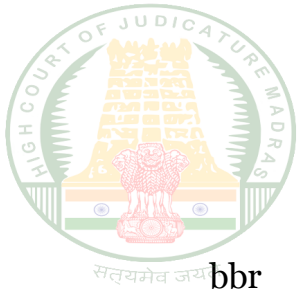
