To set aside the final order dated 07.09.2021 passed in WP No.22329 of 2017 of this Court and allow this Writ Appeal.

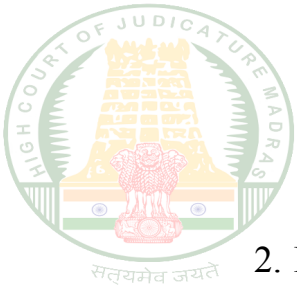
