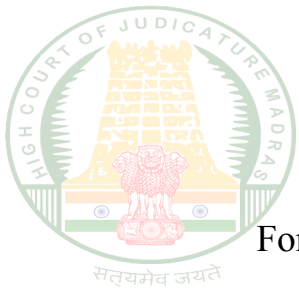
2. Accordingly, this writ petition stands closed. No costs. Consequently, connected miscellaneous petition, if any, is also closed.
