COMMON JUDGMENT

(Delivered by Dr. ANITA SUMANTH.,J)

Mr.Swaroop, learned counsel appearing for the appellant, makes an endorsement to withdraw these writ appeals, recording which these writ appeals are dismissed as withdrawn.

2. In the order under appeal that is dated 14.02.2020, learned Judge has in fact set aside the impugned assessment orders directing the authorities to complete the assessments de novo.
