The writ petition is filed seeking a direction to 1st respondent to consider the petitioner's representation dated 18.12.2024 seeking separate domestic electricity service connection for her house.

2. It is the case of the petitioner that the present electricity service connection for the petitioner's house has been classified as commercial one from 25.10.2016. Therefore, the petitioner submitted instant representation dated 18.12.2024 seeking separate domestic electricity service connection for the residential house and the same has not been considered. Hence, the petitioner has come before this Court.

3. Mr.L.Jai Venkatesh, learned Standing Counsel (TNEB), who takes notice for the respondents submitted that if the petitioner wants separate domestic service connection, it is for her to submit proper application through online. The learned Standing Counsel (TNEB) further submits that the representation submitted by the petitioner will be considered on its own merits and orders will be communicated to the petitioner.
