This writ petition has been filed seeking a writ of mandamus, directing the respondents herein to place the petitioner in the Land Acquisition - Priority Category in respect of Employment Registration No.869/10, and sponsor the petitioner's name for recruitment for the year 2014-2015 in Tiruvannamalai District.

4. In response to the notice issued by this court, the second respondent filed a counter-affidavit contending that the petitioner has not produced the relevant documents evidencing the acquisition of land belonging to him or his forefathers, and therefore, his name has not been sponsored.

No costs. Connected miscellaneous petitions, if any, shall stand closed.

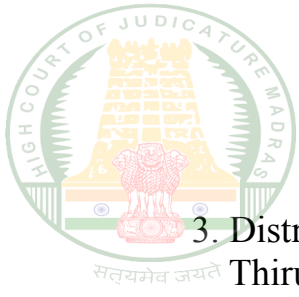
