counsel for the petitioner, the writ petitions stand dismissed as withdrawn. No Costs. Consequently, the connected miscellaneous petitions are closed.

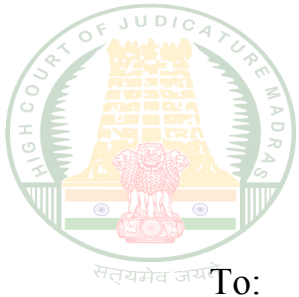
