The petitioner has filed these criminal miscellaneous petitions to modify the condition No.10(b) imposed in the orders passed by this Court dated 08.11.2024 and 19.11.2024, 08.11.2024 and 08.11.2024 in CrI.O.P.Nos.27994 & 28865 of 2024, 27960 of 2024 and 27996 of 2024 respectively.

2. Learned counsel appearing for the petitioner would submit that the petitioner was arrested in four different cases registered by the Vaniyambadi Town Police Station, Omerabad Police Station and Tirupathur Taluk Police Station at Tirupathur District and this Court, while granting bail to the petitioner, had directed the petitioner to appear before the respective respondents at 10.30a.m., and thereby, he finds it difficult to comply with the conditions imposed.

the petitioner shall appear before the Sub Inspector of Police, Tirupathur Taluk Police

Station, Tirupathur District, everyday at 10.30a.m., until further orders.

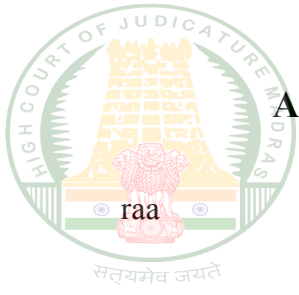
6. With the above direction, these Criminal Miscellaneous Petitions stand ordered.
