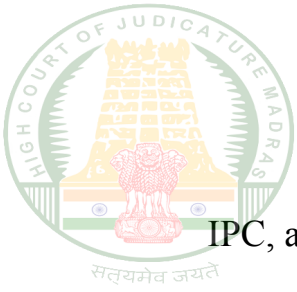

WEB COPY 2. This is the second bail application. The earlier application filed by the petitioner in Crl.OP.No.18987 of 2024, dated 22.08.2024, was dismissed by Hon'ble Mr.Justice.P.Dhanabal, with the following observations:-

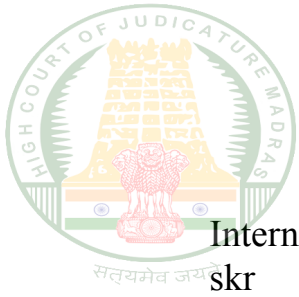
“Considering the rival submissions on either side and considering the gravity of offences, considering the fact that the petitioner is having so many previous cases and investigation is also pending, I am declined to grant anticipatory bail to the petitioner at this stage.”

3. Considering the aforesaid facts, the absence of any change in circumstances, and the fact that the petitioner has 26 previous cases, out of which 6 cases are under the NDPS Act, this court is not inclined to grant anticipatory bail to the petitioner.

4. Accordingly, this criminal original petition is dismissed.
