PRAYER : Complaint filed under Order VII Rule I and Order 34 Rule 1 of C.P.C.,
r/w. Order 37 of Original Side Rules, to pass the following decree,

(a) Directing the defendants 1 to 5 to pay the plaintiff a sum of Rs.65,81,107.00 being the aggregate amount due with future service charges at 4% per annum from the date of complaint till date of realization and penal interest at 18% from the date of complaint till the date of realization and the cost of the suit on or before a date to be specified by this Court;

(b) If defendants 1 to 5 failed to pay the decree amount claimed in clause supra direct the schedule A mentioned land building and schedule B mentioned complaint and machinery to be sold in public auction and appropriate the sale proceeds for the decreed amount after defraying the expenses of sale without prejudice to plaintiff's right to execute the decree in any other mode;

(c) pass a personal decree against the defendants two to five on account of their personal guarantee.
