ORDER

The petitioner herein seeks a direction to 2nd respondent to provide electricity service connection to petitioner's premises in Survey No.132/5A with an extent of 3347 Sq.feet vide Plot No.HIG-15 in Narasingapuram Village, Attur Taluk, Salem District by considering his online application dated 29.11.2024.

2. It is the case of the petitioner that he is the owner of the above mentioned premises and filed an online application seeking domestic electricity service connection. Though the online application was submitted as early as 29.11.2024, till date the same has not been considered. Hence, the petitioner has come before this Court.

3, Mr. I. Syed Sibquthullaa, learned Standing Counsel (TANGEDCO), who takes notice for the respondents 1 and 2, submitted that the online application of the petitioner will be considered on its' own merits on payment
