2. When the matter came up for hearing on 05.03.2025, this Court passed the following order:

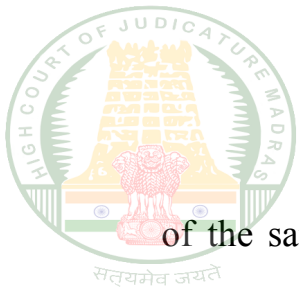
