It is the case of the petitioner that his attempts to obtain a certified copy of the Trust Deed in respect of "Tiruporur Kappal Ramasamay Nadar Amaravathi Trust" which was required for submission in a Civil Suit seeking to nullify the Trust, have been unsuccessful. The request for a certified copy, made on 25.11.2024 and received by the second respondent on 27.11.2024 has yet to be fulfilled.
