2. Recording the submission made by the learned counsel for the petitioner, this writ petition is dismissed as infructuous. There shall be no order as to costs.

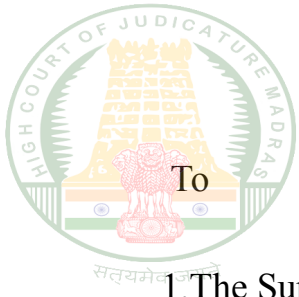
