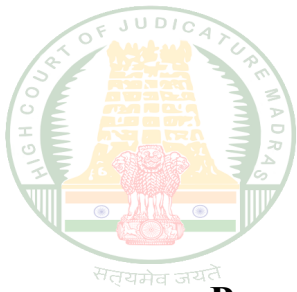

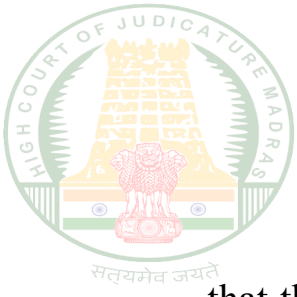

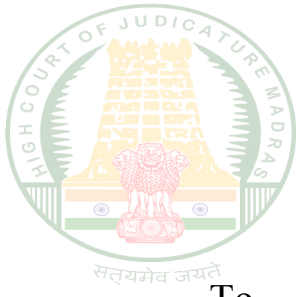
3. Therefore, this Court suo motu impleads the District Revenue Officer, Kanchipuram, as the 4th respondent.
