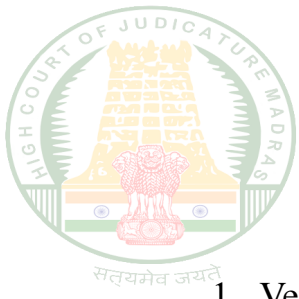

This case came up for settlement before the National Lok Adalat. The learned counsel appearing for the petitioner Mr.J. Michael Visuvasam is present.

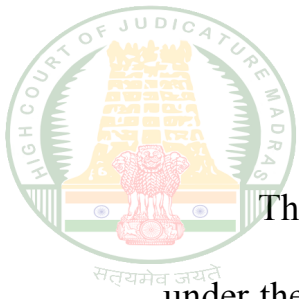
ORDER
