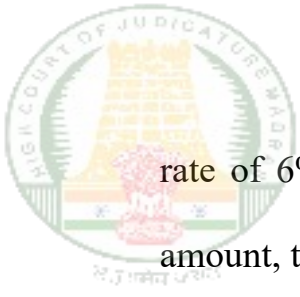
ORDER

The writ petition on hand has been filed for the following relief:

“praying for issuance of a writ of Mandamus, directing the respondents to pay the petitioner the difference amount of Rs.44,131/- towards leave salary and revised pension arrears from January 2017 to September 2019 with interest award costs.”

2. The case of the petitioner is that he was appointed as Technical Trainee in the respondent corporation on 21.07.1981 and he retired from service on 31.12.2016 as Foreman, on attaining the age of superannuation. It is the grievance of the petitioner that the respondents have not settled the revised/terminal benefits such as difference in leave salary and revised pension arrears amount to the petitioner. The petitioner had also submitted his representation dated 21.12.2021, to the respondents, seeking revised service/terminal benefits, with interest, but the same has not been considered by the respondents to date. Hence, this present writ petition has been filed.

3. Learned Standing Counsel for respondents fairly conceded that the petitioner is entitled to revised pay as per the terms of 12(3) Settlement, arrived at on 04.01.2018 and that they are willing to pay the same with interest at the



rate of 6% per annum for the belated payment on the eligible and admissible amount, to the petitioner.

4. Heard learned counsel for both the sides and also perused the records.

5. In view of the above submission of the learned Standing Counsel, this Court deems it appropriate to direct the respondents to pay the eligible and admissible amount with interest at the rate of 6% per annum for the belated payment of terminal benefits, from the date of retirement till the date of actual disbursement of the terminal benefits to the petitioner, within a period of 12 weeks from the date of receipt of a copy of this order.

6. With the above directions, this Writ Petition stands disposed of. No costs.
