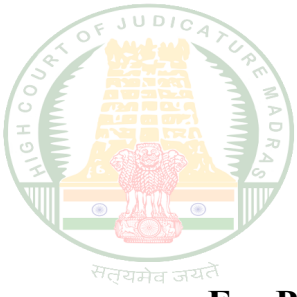

No costs.

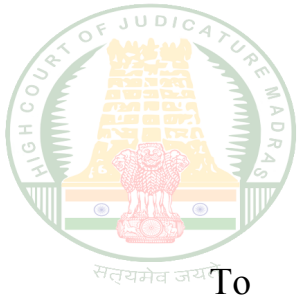
