JUDGMENT

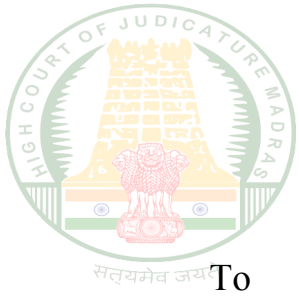
