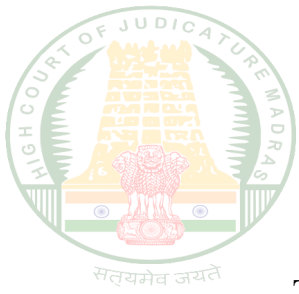

ORDER

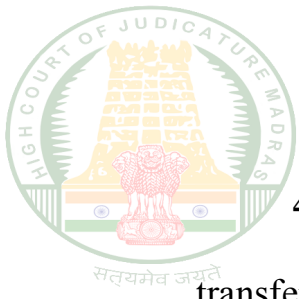

2. The respondent though served has not entered appearance either in person or through counsel. Heard the counsel for the petitioner.

3. Reasons for seeking transfer are as follows:-

(i) The petitioner wife has filed HMOP No.14 of 2022 on the file of the Principal Subordinate Court, Chengalpattu, seeking restitution of conjugal rights and the respondent husband has also entered appearance in the same.
