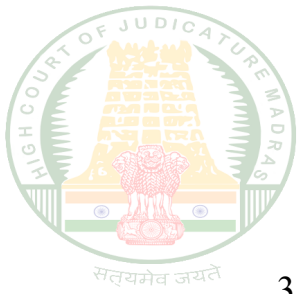

ORDER

This Criminal Miscellaneous Petition is filed to release and payout the deposit of Rs.1,00,000/- (Rupees One lakh only) standing to the credit of Crl.M.P.No.13261 in Crl.R.C.SR.No.41832 of 2019 as per the credit certificate issued by the Registry of this Court in Roc.No.11/2023/A2/Accts under due process of law.

2.The respondent/husband in M.C.No.305 of 2016 had filed the above revision challenging the order passed in M.C.No.305 of 2016 with a delay petition in Crl.M.P.No.13261 of 2019 in Crl.R.C.SR.No.41832 of 2019. This Court, by an order dated 30.09.2019, directed the petitioner to deposit a sum of Rs.1,00,000/-. Pursuant to the same, the petitioner deposited the amount of Rs.1,00,000/- in the Court deposit. Thereafter, the delay was condoned. The revision was numbered as Crl.R.C.No.1174 of 2019. After adjudication, this revision was disposed of by this Court on 09.06.2022.
