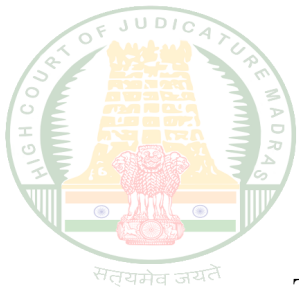

ORDER

This petition has been filed to withdraw the M.C.O.P No. 4375 of 2018 which is pending on the file of the learned IV small Causes Judge, Chennai and transfer the same to the Subordinate Court, Pudukkottai.

2. The respondents though served have not entered appearance either in person or through counsel. Heard the learned counsel for the petitioner.

3. It is seen from the records the petitioner is residing at Pudukkottai, and he has filed a petition in M.C.O.P No. 4375 of 2018 for compensation, on the file of the IV Small Causes Court, Chennai, because the accident was occurred at Chennai-Tindivanam National Highways Road, near Karpaga Vinayaga College, Chinna Kolambakkam, Kanchipuram District. Now, he is facing difficulties to attend the case since because distance between his residence and Chennai is nearly 700 kilometers.
