This Criminal appeal has been filed to set aside the judgment dated 26.04.2011 passed by the learned Additional Sessions Judge, Fast Track Court, Thirupathur, Vellore District in S.C.No.357 of 2007 and to convict the accused/respondents 2 to 5 and sentence them for an offence under Section 302 IPC.
