ORDER

The writ petition has been filed seeking a writ of mandamus to direct respondents 2 and 3 to permit the petitioner to participate in the general transfer counselling for B.T. Assistant before 21.02.2022.

2. The relief claimed in the writ petition has become infructuous, as the counselling for the 2022 has already been completed. However, from a reading of the affidavit filed in support of the petition, it is seen that the petitioner's application has not even been considered by the respondents for the counselling held in the year 2022.
