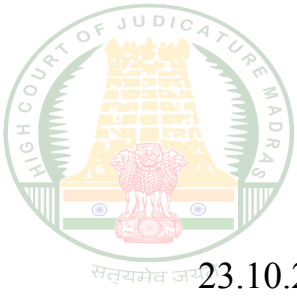

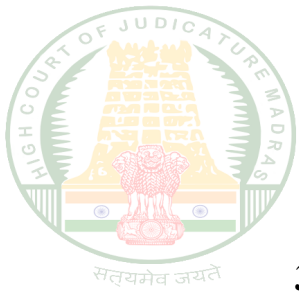

ORDER
