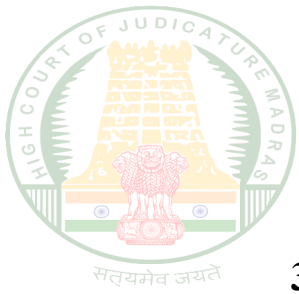

3. The proceedings of the 3rd respondent which is sought to be quashed is only a show cause notice demanding interest on the delayed payment of ESI contribution. The petitioner has rushed to this Court seeking to quash the same without issuing reply or filing an original petition before the ESI Court under Section 75 (1) (G) of the ESI Act.

4. Therefore, considering the fact that it is a show cause notice that is sought to be challenged, the Writ Petition is disposed of directing the petitioner to submit their explanation to the show cause notice and on such explanation being offered the same shall be considered by the 3rd respondent who shall consider the merits of the case and pass orders accordingly. No costs. Consequently, the connected Miscellaneous Petitions are closed.
